

RESOLUTION NO. R6-2008

A RESOLUTION AUTHORIZING THE CITY MANAGER JOSEPH J. DENEN, OF THE CITY OF WASHINGTON COURT HOUSE TO AWARD A CONTRACT TO MARK FINCHUM EXCAVATING FOR THE DEMOLITION OF 230, 232 AND 236 EAST COURT STREET AND ASSOCIATED STRUCTURAL REPAIRS.

WHEREAS, the City Council of the City of Washington Court House desires that 230, 232 and 236 East Court Street be demolished and related structural repairs be completed in order to facilitate the construction of a new Police and Fire Structure to serve the people of Washington Court House, and

WHEREAS, the City Council after due consultation with the Administration considers the procurement of a contractor for the purpose of demolition of 230, 232 and 236 East Court Street and related structural repairs advisable, and

WHEREAS, the City of Washington Court House having advertised for bids for the demolition of 230, 232, and 236 East Court Street and related structural repairs considers the authorization of a contract for said services desirable, and

WHEREAS, the Architect retained by the City of Washington Court House, "WDC Group" for the purpose of supervising the construction of a new Police and Fire structure and appurtenances thereto recommends the bid of Finchum Excavating, and

WHEREAS, the Safety and Service Committee of the City Council of the City of Washington Court House having reviewed the recommendation of the WDC Group, the recommendation of the Administration and the other bids submitted to the City of Washington Court House on February 11, 2008 elected to recommend the bid of Mark Finchum Excavating to the City Council of the City of Washington Court House.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WASHINGTON COURT HOUSE, FAYETTE COUNTY, OHIO:

SECTION 1. That the City Manager, Joseph J. Denen, of the City of Washington Court House has prepared plans and specifications and advertised for bids. A project manual including specifications for public inspection residing in the office of the City Manager.

SECTION 2. That the City Manager, Joseph J. Denen, of the City of Washington Court House is hereby authorized to accept the lowest and best bid of **One Hundred and Fifty-Seven Thousand Five Hundred Dollars and no cents (\$157,500.00) from Mark Finchum Excavating** for the demolition of 230, 232 and 236 East Court Street and related structural repairs and to sign all documents necessary for the completion of the project.

SECTION 3. That this Resolution shall take effect and be in full force from and after the earliest

date permitted by law.
